#### MANAGER'S REPORT - OCTOBER 2025 (cont.)

#### Strategic Plan update.

Major update to be released and presented at the AGM, come along if you wish to ask questions!

#### **IN PROGRESS**

Clubhouse Lounge Ceiling. NO UPDATE This was scheduled for July 2025 and we commenced the process at that point in time. Our pro-bono plasterer has engaged another contractor to assist and unfortunately it appears this will be a considerably bigger job than first thought (and quoted). The entire ceiling will need to be removed (rather than covered with new board). We are currently obtaining quotes.

Change the sand in seven bunkers. Repair the drainage and change the sand in four others, fill in and grass two others. (Perform 50% of).

In accordance with our Bunker audit, we will be fully renovating the 1<sup>st</sup> hole left greenside. The 17<sup>th</sup> hole left greenside, 8<sup>th</sup> hole front right greenside. We will also replace the sand in the 2<sup>nd</sup> hole, 3<sup>rd</sup> hole x 2, 5<sup>th</sup> hole, 8<sup>th</sup> hole and 14<sup>th</sup> hole. NO UPDATE since last report.

**Perform minor renovations to the female change rooms.** Finance has approved the flooring replacement, when Wood St Style and Flooring are available, it will be replaced. UPDATE: The flooring in the cubicle has been installed. Next, we will attack the vanities and the floor directly in front of them. NO UPDATE since last month's report however some correspondence with the Wednesday committee of the allocation of funds and timing of the works has started.

#### IF TIME PERMITS

(Perform 50% of) Repair or reconstruct the golf course paths rated a high priority. 5<sup>th</sup> to 6<sup>th</sup>, 6<sup>th</sup> to 7<sup>th</sup>, 7<sup>th</sup> to 8<sup>th</sup> & 10<sup>th</sup> to 11<sup>th</sup>. UDPATE: Unfortunately, due to the limited staff resources on the course we will not be in a position to start the path reconstructions. UPDATE. Throughout the next 6 months we hope to catch-up on the above high priority bunker works. Unfortunately, we are back to two staff for the short term which will delay the process a month or so. UPDATE: From the week of Monday July 7<sup>th</sup> we will be back to full strength and whilst there will be a staff training period we will hopefully get to the paths over winter. UPDATE: We have engaged contractors to provide us with advice relating to the construction of a <u>permanent</u> pathway from the 18<sup>th</sup> green to the clubhouse (with a 10<sup>th</sup> tee connection) COM are currently weighing up the associated costs. We expect to reconstruct the pathway in the Next two months, whether it be hex grid/crushed rock, concrete, asphalt or similar remains to be determined. **UPDATE:** COM have approved the construction of a hex grid pathway with concrete culvert drainage from the clubhouse to the 18th green (via a new cutaway through the garden bed to the front of the 18th green (and onwards to the women's 10<sup>th</sup> tee. We expect this to commence within the month (contractor dependent for the Culvert drain).

#### **RESULTS V BUDGET**

**Income** is under by \$11,500 (not so good).

- Competition Fees & Subscriptions are the two main areas that are trailing budget.
- All other areas are either meeting budget or exceeding.

Expenses are under \$10,000 (good).

- Essentially all areas, on average, are meeting budget.
- The main area exceeding budget is an Insurance refund we have received.

**Net Profit** (against budget) is under by \$1,300 (not so good), if we keep in mind the Insurance refund that was not expected, we would have been under budget by \$11,300. Our Net Trading Profit is \$41,000 (before Depreciation) against a budget of \$42,600.

I am happy with the way we are tracking, and look forward to some good weather as we head into the holiday period.



Both greens have been treated with wetting agents, insecticide and fungicide.

The bottom green renovation will be done Tuesday 8th November and will be out of action for as long as it takes to recover.

This puts extra pressure on our top green so all social bowls to be played east west leaving north south for Pennant and Club events.

We will all have to share the top green with social bowlers so everyone gets a game. We need to be very mindful of excessive wear with regular changing of direction of play, and rolling.

I know players do not like east west but if we do not do this we will very soon have no grass cover on north south rinks making it unplayable for us all. Rink numbers will be moved to give 6 rink play or 7 rink play where required to spread the wear to over different areas.

The top green will be scarified, fertilised and groomed very soon to improve the growth and playing surface. We all must be patient while this work is done and recovery is complete.

#### SPECIAL RESOLUTION TO AMEND THE CONSTITUTION OF THE BAIRNSDALE GOLF CLUB INCORPORATED AT THE 2025 ANNUAL GENERAL MEETING

#### To be held on Tuesday 25th November 2025 at 6 pm

Clause 28 be changed to read as follows "The election of Committee Members shall commence on the third Tuesday in October each year and conclude on the following Saturday. Voting will be open at specified times on each day.

Clause 33.1 be changed to read as follows "If nominations for any positions on the Committee exceed the number required to fill those positions, a secret ballot must be arranged by the Returning Officer.

Clause 33.3.2 be changed to read "the eligibility of members to vote, the method of voting, the commencing and concluding dates and times of the ballot; and

Clause 34.4 be changed to read "Following the count of all votes received, the Returning Officer shall declare the result of the ballot which will be confirmed at the AGM.

These changes will allow members to vote on five days at nominated times, and if a secret ballot is required will be arranged by the Returning Officer. Result of any ballot will be announced immediately and confirmed at the Annual General Meeting. Copy of the clauses with changes highlighted in blue are shown below.

#### Division 2 - Election and Tenure of Office

#### 28. Election Day

The election of Committee Members shall commence on the third Tuesday in October each year and conclude on the following Saturday. Voting will be open at specified times on each day.

#### 33. Election by Ballot

- 33.1 If nominations for any positions on the Committee exceed the number required to fill those positions, a secret ballot must be arranged by the Returning Officer.
- 33.2 A secret ballot shall:
  - 33.2.1 be conducted entirely by means of lodging a vote; and
  - 33.2.2 conclude at close of voting on the day designated in rule 28.
- 33.3 During a ballot, the notice board referred to in rule 30.2 shall display advice regarding:
  - 33.3.1 the nominees for election including their supporting material; and
  - 33.3.2 the eligibility of members to vote, the method of voting, the commencing and concluding dates and times of the ballot; and
  - 33.3.3 such other details in relation to the election as the Committee deems necessary including any photographic identification and résumés of nominees.

# **Duties of the Marker**

With some of our singles events both under way and coming up, it may be timely to look at the 'Duties of the Marker'. A good marker can make or break a game. If you cannot stand for the duration of the game, maybe you should not be marking, or if you are tired, get a replacement marker.

These hints have been compiled by the Queensland State Umpire Committee.

**DO** be correctly attire and equipped (chalk, pen & card).

**DO** challenge the length of the jack roll if in doubt. <u>It is your duty</u> to ensure the jack is at least 21 metres.

**DO** answer any specific questions about the state of the head which is asked by the player in possession of the rink. Do not offer any opinions.

**DO** know the definition of a 'jack high' bowl.

**DO** mark all touchers with chalk and remove chalk marks from non-touchers as soon as they come to rest.

**DO** stop any bowl from a neighbouring rink which is likely to disturb the head.

**DO** not move, or cause to be moved, either the jack or any bowls until the players have agreed the number of shots.

**DO** record the score <u>after the players have agreed</u> to the number of shots and tell the players the running total after each end.

Keep clear of the head when the players arrive—they determine the result, not you!

**DON'T** raise the jack above your head before you place it on the 'T' mark.

**DON'T** say a shot is doubtful if it is not really so.

**DON'T** invite the player to inspect the head.

**DON'T** talk to spectators on the bank.

**DON'T** supplement your answer with information not asked for.

Remember, you are there to help the players, not be a part of their game.


